WARRENVILLE PARK DISTRICT

AN ORDINANCE DETERMINING THE GENERAL PREVAILING RATE OF WAGES FOR LABORERS, MECHANICS AND OTHER WORKERS ENGAGED IN CONSTRUCTION OF PUBLIC WORKS COMING UNDER THE JURISDICTION OF THE WARRENVILLE PARK DISTRICT FOR THE PERIOD OF JUNE 1, 2017, THROUGH JUNE 30, 2018

WHEREAS, the State of Illinois has enacted "An ACT regulating wages of laborers, mechanics and other workers employed in public works by the State, county, city or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 1941, codified as amended, 820 ILCS 130/1 et seq. (1993) formerly Ill. Rev. Stat. 1987, Ch. 48, Par. 39s-1 et seq., and

WHEREAS, the aforesaid Act requires that the Warrenville Park District investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Warrenville Park District employed in performing construction of public works for said Warrenville Park District.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF PARK COMMISSIONERS OF WARRENVILLE PARK DISTRICT:

SECTION 1: To the extent and as required by "An ACT regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 1941, as amended, the general prevailing rates of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Warrenville Park District are hereby ascertained to be the same as the prevailing rates of wages for construction work in the Du Page County area as determined by the Department of Labor of the State of Illinois as of June of 2017, a copy of that determination being attached hereto and incorporated herein by reference as Exhibit A. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and shall thenceforth apply to any and all public works construction undertaken by the Warrenville Park District. The definition of any terms appearing in this Ordinance which are also used in aforesaid Act shall be the same as in said Act.

SECTION 2: Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Warrenville Park District to the extent required by the aforesaid Act.

SECTION 3: The Warrenville Park District Secretary shall publicly post or keep available for inspection by any interested party in the main office of the Warrenville Park District this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

SECTION 4: The Warrenville Park District Secretary shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5: The Warrenville Park District Secretary shall promptly file a certified copy of this Ordinance with both the Department of Labor and Secretary of the State of Illinois.

SECTION 6: The Warrenville Park District Secretary shall cause a notice of adoption of this Ordinance to be published in a newspaper of general circulation within the area and such publication shall constitute notice hereof for all purposes.
