# ANNUAL REPORT

## SUMMARY

The 2020–2021 fiscal year was certainly challenging, as the Park District temporarily shut down mid-March due to the COVID–19 pandemic. We anticipated, prepared, adjusted and embraced changes along the way while keeping steadfast to our mission – providing opportunities that enrich the mind, body and spirit. There was a new level of innovation necessary as the importance of parks and recreation became evident during the pandemic. A virtual recreation campaign was launched on social media during the stay-at-home order bringing ideas, activities and story times to our community. As new guidelines were in place, staff and patrons safely returned to our facilities and programs and events were held when they were greatly needed by the community. Innovation continued into the fall and moving forward, we will pivot when necessary and bring creative and new programs to meet the needs of our community.

#### **OUR VISION:**

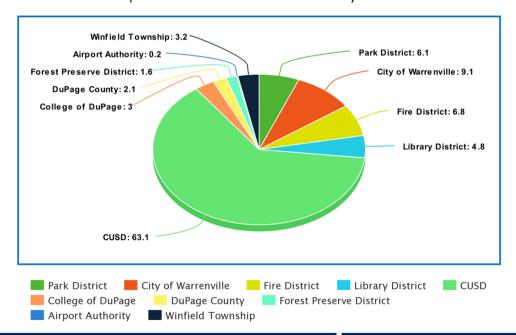
We strive to be an innovative park district that is recognized by our community as a provider of exceptional parks and recreation services.

#### FINANCIAL ANALYSIS

In a typical fiscal year, the total annual budget is approximately \$4 million dollars of which approximately 65% is funded by property tax revenue. The remaining 35% is generated through program user fees, grants and rentals. Since the COVID-19 pandemic, district program fees were impacted by approximately \$480,000 due to lost revenue, refunds and credits. To offset the financial impacts, the District:

- Furloughed over 40 part-time staff in spring, many of whom were brought back as programming and operations expanded
- No merit pool salary increases
- Delayed replacement of FT Parks Department vacancy
- No gatherings conferences, events, holiday party, staff outings
- Performed custodial function in-house for over three months
- Recovered 100% camp & active adult trip deposits
- Summer Camp eliminated trips, bussing, t-shirts, reduced supplies
- Transferred Summer Daze contracts to the 2021 event
- Received donated ballfield mix from Winfield Park District

The new **Wiffleball Home Run Derby** had 11 participants swinging for the fences.

The rescheduled **Brew Trot** had 96 participants running/walking to their reward at the finish line.

**Art on the Prairie** featured 20 local artists for a weekend of art and music for the community.

**Youth Fall Soccer** had 113 participants take the field for practices and scrimmages.

**Youth Fall Dance** welcomed 42 dancers to the dance floor.

# SPECIAL EVENTS & PROGRAMS, CONT'D

**Fall Softball League** had 7 Men's teams compete.

The traditional Fall Fest was modified to a **Fall Fest Boo-To-You Parade / I Spy Ghost Hunt.** 167 people completed the ghost hunt and the parade was a welcome celebration for the community.

Our traditional Holly Days event was modified to a **Holly Days Drive-Thru**. We had an unexpected and amazing turnout with an estimated 1,000 cars visit the event.

Our new **Boredom Buster Bags** offered at-home activities for kids with 309 participants.

Spring Soccer had a record 155 participants.

**It's a Zoo** replaced the Father/Daughter and Mother/Son Dances with 60 participants.

The **Flashlight Egg Hunt** took place with 10 different time slots and 215 participants.

You've Been Egged! Basket Deliveries replaced the Bunny Breakfast with 30 home delivered Easter surprises.

The **Winter Spring Dance Show** took place in the WCB Gym with 3 mini-shows and 46 dancers.







#### **SUPPORTING LOCAL:**

The Warrenville Park District facilitated Community Blood Drives in partnership with Versiti in September, December and April. 55 total pints of blood were collected.

Staff collected donations in December for Toys for Tots.

Staff created Valentine's Day cards and sent them to local seniors.
