Eligibility/Standards: This is a juried fine arts and fine crafts fair. All work must be original by the artist, who must be age 16 or older.

No molds, manufactured or kit art permitted.

Photography is permitted.

Please submit four high-resolution digital images on a CD-ROM or by email to <u>ruthb@warrenvilleparks.org</u> (three representing the work you are bringing and one of your display booth). Be sure that your photos show a consistent body of work. Mail or email an artist statement with your experience and an explanation of your creative process.

Groups of artists are accepted, however, each artist in the group is juried separately. Each artist must submit 3 jpegs of his or her work. Please submit images and applications in one package.

Cash Awards: Mayor's Choice and Awards of Excellence, are presented Saturday afternoon, Sept. 20.

Liability: Each artist assumes full responsibility for the care, safety and security of his/her works and property. By signing the application form, each artist agrees that Art on the Prairie is not responsible for the loss or damage to works and waives any claim from any cause.

Exhibition: A <u>10 x 10 ft. space</u> is allotted to each artist or group of artists with 1 ft. on either side of the space. All artists must supply their own booth structures, as well as display boards, tables and chairs. *Exhibitors are required to provide a TENT and 4 PROPER WEIGHTS; NO Staking in the ground is allowed.*

<u>Limited number of tents for rental for \$50</u> <u>including weights.</u>

Artists are responsible for set-up of their booths, which must be installed by <u>**9am on Sept. 20 & 21, 2025.**</u> Artists are required to remain set up until closing. Artists must be present, no dealer/agents stand-ins, unless pre-arranged with the show promoter. No commission is charged and sales tax is the responsibility of the artist
