

ORDINANCE NO. 2025-17

WARRENVILLE PARK DISTRICT

**AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE
FISCAL YEAR
BEGINNING MAY 1, 2025 AND ENDING APRIL 30, 2026**

BE IT ORDAINED by the Warrenville Park District ("District") and the Board of Commissioners of the Warrenville Park District of the County of DuPage, State of Illinois:

Section 1: That the sum of \$4,409,000 comprised of the sum of \$2,967,000 for general corporate purposes, the sum of \$767,000 for recreational programs, the sum of \$131,000 for payment of the costs of protecting the park district and its employees against liability, property damage or loss, the sum of \$414,000 for recreation for the handicapped, and the sum of \$130,000 for the payment of the principal and interest on bonded indebtedness, be and the same is hereby levied for the fiscal year beginning May 1, 2025 and ending April 30, 2026, and assessed on all real property within said District subject to taxation according to the ad valorem value of the same property as the same is assessed and equalized for state and county purposes; that said amount of \$4,409,000 to defray the necessary expenses for the operation, construction, repair, improvement and maintenance of the park grounds and improvements possessed and under the control of the Warrenville Park District, for recreational programs, for payment of the costs of protecting the park district and its employees against liability, property damage or loss, for recreation for the handicapped, and for the payment of principal and interest on bonded indebtedness, is to be collected from the tax levy for the year 2025 in accordance with this ordinance and as authorized to be made by statute.

Section 2: The objects and purposes for which this levy is made and the respective amounts thereof are hereby set forth and levied as follows:

Section 3: That the County Clerk be and is hereby directed, as provided by law, to ascertain the rate percent which, upon the total valuation of all real property subject to taxation within the Warrenville Park District as the same is assessed and equalized for state and county purposes, will produce a net amount as herein legally levied, and to extend such tax pursuant to the statute in such case made and provided.

Section 4: That the Secretary of said District be and is hereby directed to file with the County Clerk of DuPage County, Illinois, within the time limited by law, a copy of this ordinance, duly certified by her, and accompanied by the certificate of the President of such District certifying compliance by said District with the applicable provisions of the Truth in Taxation Act.

Section 5: That this Ordinance shall be in full force and effect immediately upon its adoption.





**Notice of Proposed Property Tax Increase
for Warrenville Park District**

- I. A public hearing to approve a proposed property tax levy increase for Warrenville Park District for 2025 will be held on December 18, 2025 at 5:00 p.m. at the Warrenville Park District Recreation Center, 3S260 Warren Avenue, Warrenville, Illinois 60555. Any person desiring to appear at the public hearing and present testimony to the taxing district may contact Tim Reinbold, at 3S260 Warren Avenue, Warrenville, Illinois 60555, Tel.: 630-393-7279.
- II. The corporate and special purpose property taxes extended for 2024 were \$3,484,338.

The proposed corporate and special purpose property taxes to be levied for 2025 are \$4,279,000. This represents a 22.8% increase over the previous year.

- III. The property taxes extended for debt service and public building commission leases for 2024 were \$131,561.

The estimated property taxes to be levied for debt service and public building commission leases for 2025 are \$130,000. This represents a 1.2% decrease from the previous year.

- IV. The total property taxes extended for 2024 were \$3,615,898. The estimated total property taxes to be levied for 2025 are \$4,409,000. This represents a 21.9% increase over the previous year.
